The Academic Articles provide that, with regard to certain matters, the President may designate another individual to assign a classification or to approve, authorize, or make an appointment. Likewise, the Academic Articles provide that, with regard to certain matters, the Provost may designate another individual to assign a classification or to approve, authorize, or make an appointment. The Academic Articles also provide that the "Office of the Provost" has authority over certain decisions. The purpose of this memorandum is to specify whom the President and Provost have selected to act on their respective behalf as a designee, where authorized by the Academic Articles, and to clarify who has authority to act on behalf of the "Office of the Provost" as that term is utilized in the Academic Articles. All power and authority not expressly delegated in this memorandum is reserved and retained by the President and Provost.
